Die Tanzmesse ist unverzichtbar!

Sie ist mit IDAS NRW einer der beiden Brückenpfeiler des internationalen Austauschs der vom Land NRW und den Kommunen geförderten Tanzproduktionen aus NRW. Die Gastgeberschaft für eine internationale Plattform in NRW/Deutschland ermöglicht Einladungen und Koproduktionen im Ausland für die Künstler:innen! Vor Allem für Produktionen der Freien Tanzszene ist der Austausch mit den internationalen Partner:innen für die Existenzhaltung entscheidend!

Seit etwa 2003 arbeite ich in Köln als Choreografin. Als ich 1998 nach Deutschland kam, erfuhr ich zum ersten Mal von der Existenz der Tanzmesse. Ich erinnere mich noch gut daran, wie überrascht und gleichzeitig begeistert ich war, denn ein Forum wie dieses gibt es in Japan nicht – vielleicht nicht einmal auf der ganzen Welt. Die Möglichkeit, ein internationales und lokales Netzwerk in einem so großen Umfang aufzubauen, ist einzigartig. Die Tanzmesse hat mir als unabhängige Choreografin, die kleinere Projekte präsentiert, die Tür zu einer Welt geöffnet, in der ich internationale Kontakte knüpfen konnte, die sonst unerreichbar geblieben wären – unabhängig von der Größe der Kompanien oder einer möglichen Anbindung an feste Theater. Die internationale tanzmesse nrw ist weit mehr als eine Veranstaltung. Sie ist ein unverzichtbares Forum für den Austausch, das Verständnis und die Weiterentwicklung des zeitgenössischen Tanzes. Ihr Fortbestand ist von unschätzbarem Wert – sowohl für die internationale Tanzszene als auch für die lokale Kultur in NRW. Während vieles heute online möglich ist, bleibt der Tanz in seiner Essenz eine Kunstform, die durch Live-Präsenz und direkte Begegnung erlebt werden muss. Sein wahrer Wert erschließt sich erst im unmittelbaren, persönlichen Erleben – eine Erfahrung, die digitale Formate nicht ersetzen können. Angesichts der oft betonten Bedeutung einer "nachhaltigen Gesellschaft" stellt sich die Frage: Warum sollte eine Plattform, die über 30 Jahre hinweg gewachsen ist, aufgegeben werden? Statt sie zu beenden, sollten wir alles daransetzen, diese nachhaltige Struktur zu erhalten und weiterzuentwickeln. Der Wegfall der Förderung bedroht nicht nur eine über Jahrzehnte etablierte Plattform, sondern schwächt auch die gesamte zeitgenössische Tanzszene – auf lokaler wie globaler Ebene. Die Tanzmesse ist mehr als nur eine Veranstaltung: Sie ist ein essenzielles Instrument für internationalen Austausch und die nachhaltige Entwicklung.

*An der internationalen tanzmesse nrw war die Ben J. Riepe Kompanie in den letzten Jahren auf unterschiedliche Weisen beteiligt: Als NRW-basierte Kompanie während der Pre-Days, als Kollaborationspartnerin für kleinere Veranstaltungen mit dem FREIRAUM, oder im tanzmesse-Programm mit einer aus fast tausend Bewerbungen ausgewählten Produktion für den Showcase 2022. Besonders während der letzten zwei Editionen war regelrecht spürbar, wie die tanzmesse nicht nur die gesamte bundesdeutsche Tanz- und Performanceszene durch den direkten Austausch, die Möglichkeit von Live-Begegnungen und Live-Erfahrungen von Kunst und Künstler*innen von allen Kontinenten nachhaltig befruchtet hat, sondern auch, wie die Stadt und ganz NRW durch knapp 1500 Kunstschaaffende zu einem „Hub“ real wertschöpfenden Austauschs der internationalen Tanzszene wurden. Denn die Wirkung, die eine solch klug gedachte und ausgeführte Plattform wie die tanzmesse ganz real für Künstler*innen in und aus NRW erzielen kann- vor allem, wenn sie auch zukünftig, wie in den letzten Ausgaben geschehen, die regionale Szene derart relevant mit einbezieht - ist real und in Zahlen spürbar: Treffen, die hier möglich werden, führen zu internationalen Netzwerken, Arbeiten, die hier gezeigt werden, werden international programmiert. Wir selbst haben dies beispielsweise mit „Creature“ erfahren, einer Produktion, die in unmittelbarem Bezug auf die vorausgegangene Programmierung während der tanzmesse zum renommierten SAAL BIENNAL Festival nach Estland eingeladen wurde. Die internationale tanzmesse nrw ist so mehr sein als ein reines „Aushängeschild“ in Sachen Tanz und Performance für das Land NRW und die Stadt Düsseldorf: sie erzeugt Wirkung und unterstützt NRW-Künstler*innen hier vor Ort und weltweit in Networking, Sichtbarkeit und Touring. Dieses Format als weitere Struktur der Stärkung unserer Szene zu beschneiden oder gar zu kappen wird sicherlich spürbare Auswirkungen auf internationale Gastspielreisen und zukunftsorientierte Touring-Möglichkeiten in und aus NRW haben.*

Over the years, Tanzmesse has been an essential platform for the promotion and visibility of dance on an international level. For us, it has played a crucial role in showcasing Basque artists and propelling their careers onto the global stage.

This event is not merely a trade fair—it is a vital space for cultural, artistic, and professional exchange. Any organised activity by Tanzmesse NRW that welcomes/invites programmers in a certain focus/purpose, makes it much more easy for artists and/or their representatives to meet people for the first time and talk. (not necessarily only for distribution purposes, but also for exchange of information/experiences)

Before the Tanzmesse started I could make some appointments with people who already know us but also with new people. (the programmers follow also such a heavy, full program already). The organization of the pitches was nicely supported by the friendly Tanzmesse team and we came home with 15/20 concrete interests of which 5 are now already confirmed and arranged.

I also walked Agora several times in those 2 days (not possible to stay more), but I discovered many amazing looking stands of countries/foundations with lots of money, a business-context which is not ours...

As a general 'networking' opportunity I find Tanzmesse one of the more overwhelming contexts, especially if it's about making first connections.

The tanzmesse nrw is unique and irreplaceable for our work and the entire contemporary dance sector!

Die Entscheidung, die Förderung der Internationalen Tanzmesse nrw - eines der Leuchturmprojekte für den zeitgenössischen Tanz in Deutschland und weit darüber hinaus - einzustellen, können wir in keinsten Weise nachvollziehen. Die Internationale Tanzmesse nrw ist die einzige europäische Fachmesse und ein Ereignis mit gleichermaßen nationaler wie internationaler Strahlkraft und aus der Tanzlandschaft nicht mehr wegzudenken. Über 30 Jahre hinweg haben es die unterschiedlichen Leitungsteams zusammen mit dem hochprofessionellen Team des nrw Landesbüro Tanz und vielen weiteren Beteiligten geschafft, Künstler*innen, Produzent*innen, Theaterleiter*innen und Festivalmacher*innen aus der ganzen Welt biennial für sehr intensive Messtage zusammenzubringen. Die Möglichkeit, in kürzester Zeit eine enorme Anzahl von Vorstellungen unterschiedlichster Formate und Stile sowie Pitchings für neue Projekte aus der ganzen Welt zu sehen, dazu mit den Kolleg*innen Fachgespräche zu führen und neue Kooperationen zu planen oder Stücke für Häuser oder Festivals zu buchen, ist enorm attraktiv - im besten Sinne einer Messe. Hinzu kommen die vielen Workshops, Gesprächsrunden und Panel zu einer großen Bandbreite aktueller Themen, in deren Rahmen ein Austausch auf hohem fachlichen Niveau gewährleistet ist. Das Tanzbüro München ist regelmäßige Teilnehmerin der internationalen Tanzmesse nrw - wir nutzen die Veranstaltung sowohl als Plattform, um die Münchner Tanzschaffenden zu präsentieren als auch, um uns mit den (inter)nationalen Kolleg*innen zu vernetzen. Hieraus sind schon zahlreiche Kollaborationen entstanden, u.a. das internationale Austauschprojekt Meeting Points mit den Kolleginnen aus Schottland. Gerade die letzte Ausgabe an der wir - wie an vielen davor - teilgenommen haben, war sowohl in der Vielfalt und Diversität der präsentierten Vorstellungen als auch im Rahmenprogramm für die Fachbesucher*innen von hoher Qualität.

Angesichts der insgesamt bedrohlichen Weltlage, Kürzungen in vielen Städten und Ländern sowie des zunehmenden Rechtsrucks halten wir es für wichtig, Projekte, die für (künstlerische) Qualität und Diversität, den Austausch unterschiedlichster Nationalitäten, Religionen und unterschiedlicher weltanschaulicher Vorstellungen auf Augenhöhe sowie die Verständigung auf einen zivilen Umgang miteinander über alle Unterschiede hinweg nicht fallen zu lassen.

Auch für die Stadt Düsseldorf und das Bundesland Nordrhein-Westfalen ist die Veranstaltung mit ihren vielen dezentralen Vorstellungen - viele davon auch für die Bürger*innen besuchbar oder kostenfrei und niederschwellig im öffentlichen Raum erlebbar - ein nicht zu unterschätzender Standortfaktor, der in die beteiligten Städten ausstrahlt und im Messezeitraum mehrere hundert Besucher*innen nach Düsseldorf bringt. Für die Fachbesucher*innen ist die internationale Tanzmesse nrw wichtiger Teil des professionellen Lebens und auf dem gleichen Level wie Cinars, YPAM oder die ICE Hot Nordic Dance Platform. Wie Sie sicher wissen, gibt es in Europa kaum vergleichbare Formate von entsprechender Größe und dem Renommée der Tanzmesse. Dementsprechend würden wir es sehr begrüßen, wenn Sie ihre Entscheidung, sich aus der Förderung der internationalen Tanzmesse nrw zurückzuziehen, überdenken würden. Denn einmal zerstörte, gut funktionierende Strukturen wieder aufzubauen, kostet wesentlich mehr, als sie beizubehalten.

I am writing to express my shock and dismay at the news that the NRW Ministry of Culture has decided to stop funding the Internationale Tanzmesse NRW and IDAS NRW. This decision will undoubtedly undermine the international profile of Nord Rhein-Westfalia as a leading cultural region in Germany and Europe, and create irreversible damage to the NRW dance sector and the international dance community as a whole.

Scottish Dance Theatre has attended Tanzmesse for more than two decades, being invited to showcase our work onstage and regularly taking part in networking and artistic exchange events. This is an invaluable platform to meet with the international dance community and to get to know local artists from the NRW region. For example, in my recent visit to Tanzmesse in August '24, I had the opportunity to meet Düsseldorf-based choreographer Alexandra Waierstall and explore the potential of future collaborations.

From a personal perspective, Tanzmesse has played a vital role in my professional career as a choreographer. As an independent artist, I was invited to perform with my company Joan Clevillé Dance in 2016. This enabled me to strategically raise my international profile, expand my professional network and gain further opportunities to present my work. As a direct result of my participation at Tanzmesse, I was invited to present my work at the 2017 edition of the tanzmainz festival.

In short, I appeal to the relevant authorities to re-consider their decision to stop funding Internationale Tanzmesse NRW and IDAS NRW and to fully reinstate their subsidy. It is hard to believe that a region would willingly relinquish their leading role in the cultural sector after years of strategic investment. And it is alarming to see a lack of understanding of the deep impact that such a decision would have on artists, organisations, audiences and communities.

This decision jeopardizes the future of these pivotal institutions and poses a significant threat to the international networking and development of the dance scene in North Rhine-Westphalia (NRW). For over three decades, the Internationale Tanzmesse nrw has served as the largest professional meeting for contemporary dance, bringing together approximately 1.500 dance professionals from over 50 countries every two years in Düsseldorf. It has been a vital platform for artistic exchange, knowledge transfer, and the promotion of international tours and collaborations. The Tanzmesse has played an essential role in maintaining and expanding networks that have been cultivated over 30 years, contributing significantly to the global visibility of dance professionals from NRW.

Similarly, IDAS NRW has been an indispensable component of dance promotion and funding for over 15 years. As an interface between artists and presenters, it has strengthened the visibility of NRW's independent dance scene, established long-term contacts, and provided strategic support to artists.

The discontinuation of funding for these institutions not only undermines the cultural infrastructure of dance in NRW but also diminishes the region's reputation as Germany's foremost "dance region." The absence of the Tanzmesse and IDAS will weaken structural support for dance and hinder international exchange, leading to long-term cultural, economic, and socio-political losses. The international cultural exchange facilitated by platforms like the Tanzmesse is of paramount importance. The loss of such a platform would be a setback for contemporary dance and intercultural dialogue.

We urge the state government and the NRW Ministry of Culture to reconsider this decision and reinstate the necessary funding for the Internationale Tanzmesse nrw and IDAS NRW. Preserving these institutions is crucial for the continued growth and international engagement of the dance community.

Without Tanzmesse, Germany risks losing its central role as a hub for artistic exchange and innovation in dance, which would diminish its global influence and cultural leadership.

Preserving Tanzmesse is not just about maintaining a single event; it's about sustaining a unique infrastructure that has empowered countless artists, promoted cultural dialogue, and created lasting global connections. Cutting ties with the external world and reducing support for culture during times of crisis has never benefited those in need. On the contrary, it is precisely during such times that culture and international connections become lifelines for resilience, cooperation, and progress.

Tanzmesse has, for decades, served as far more than a cultural event: it is an engine of artistic innovation, a meeting point for diverse perspectives, and a critical force for cultural diplomacy. By fostering global connections, Tanzmesse strengthens NRW's reputation as a region of cultural leadership and progressive values. Its closure would not only isolate the dance community but would also diminish NRW's role as a global player in the arts sending a signal that the region is turning inward at a time when international collaboration is needed most.

You risk weakening a cultural infrastructure that generations have built, and losing the economic, social, and cultural benefits that Tanzmesse brings. By allowing it to disappear, NRW would turn its back not only on artists but on its own identity as a progressive and internationally connected state.

Germany's crises are real. But history shows that cutting culture during hardship does not solve economic or political problems. Rather, it exacerbates isolation and stagnation. Our question is: Will NRW sustain its role as a leader in the global cultural community, or will it retreat when leadership is needed most?

We implore the government of NRW to recognize Tanzmesse not as a burden, but as an opportunity: a platform for innovation, cultural growth, sustainability and unparalleled leadership in an uncertain world. Reconsider this decision and secure Tanzmesse's future for the artists, for the audiences, and for NRW's continued relevance in the global cultural landscape.
